ENTRY FEES:

Intro: 10 or 15 miles-\$80. 25 or 50 miles-\$125. 75 or 100 miles-\$200.

Junior Riders 25+miles entry fee=\$100 any distance.

Young Riders 25+miles deduct \$50 off entry fee.

Non-AERC members must pay \$20 day fee unless you are an Intro Rider.

Entries received after January 18th must pay a \$25 late fee.

A partial refund post ride is available. You must notify the ride manager on or Before January 18th.

No camping fees since this is a benefit ride.

RIDE INFO:

Hunting season is upon us, please plan on wearing bright colors.

Goethe State Forest requires all horse riders to carry a coggins copy.

We will have a silent auction on Friday to raise \$\$\$ for the forest.

Registration opens at 2pm Friday.

Vet In will start around 3pm Friday.

Friday dinner will start at 5pm. All are welcome, donations accepted.

Ride meeting will start approximately 5:30pm Friday.

Awards can be picked up upon completion or once BC judging is final.

Non-potable water is available in several locations around main camp.

Overflow camping is available.

Bathrooms are located next to the pavilion, several porta-johns available.

RIDE TIMES:

7am: 75 and 100 mile riders start

8am: 50 mile riders start 8:30: 25 mile riders start 9am or later Intro Riders start

CAMPING: Primitive sites only. No showers, there is a small bathroom next to the pavilion. Porta-johns are placed around the main camping area. Non-potable horse water is available in the main camp area.

TRAILS: Some packed sand, some deep sand, packed limestone roads, many with a berm along the edge. Shoes are recommended.

FOOD: Friday night dinner will consist of a variety of homemade dishes, something for everyone. Volunteers and Vets will be fed from beginning to the end of the ride.

RULES: All dogs must be on a leash, tied or contained. This is a park rule. Approved safety helmets when mounted are required for all riders. All AERC, SERA and SEDRA rules apply. Decisions of vets are final. Equines must be at least 48 months old to enter the LD, 60 months old to enter the 50 or 75 mile ride and 72 months old to enter the 100 mile ride. Riders under 16 must be accompanied by a designated adult rider (21 years or older) for the duration of the ride.

You are responsible for knowing and adhering to the rules for the event you enter. A negative coggins within the past year is mandatory.

Under Florida Law, an equine activity sponsor or equine professional is not liable for injury to, or death of, a participant in equine activities resulting from inherent risks of equine activities, Chapter 773.
