NEGATIVE COGGINS REQUIRED AT CHECK-IN FOR ALL HORSES. ALL HORSES SHOULD BE PRESENTED FOR PRE-RIDE VETERINARY INSPECTION BY 6:00 P.M. ON THE DAY PRIOR TO THE RIDE. PLEASE NOTIFY RIDE MANAGEMENT IF YOU EXPECT TO ARRIVE LATE.

RIDE TO START AT APPROXIMATELY 7:00 A.M, but may change due to distance and Sunrise.

Pre-Entry appreciated but not required, LATE entry IS AN ADDITIONAL \$50 FOR ENTRIES received AFTER November 20, 2024. A PARTIAL refund will be made post ride if you're unable to attend and notify the ride manager before November 20, 2024, Ride Management will be on site starting November 22, 2024.

CAMPING: "THE WINERY" (near Sugarloaf Mountain). Semi-primitive camping.

Please keep dogs on a leash. Port-a-poties WILL BE located in camp.

TRAILS: Great trails. The cooperation of many area landowners makes it possible for us to have a great trail that consists mostly of flat, sandy dirt roads. Water buckets will be available along trail. Terrain is flat. Shoes/hoof protection recommended for the longer distances – gravel has been added in spots. Please consider your particular horse's hoof protection needs.

Please be considerate and don't block parking areas for other riders! There is overflow parking available at the airstrip across from the Main Camp. GENERATORS will be allowed to run from 5 am until 10 PM each night with the exception of Saturday night during the 100 mile ride. They will be allowed all night on Saturday night.

If you plan to arrive by Wednesday, November 27, 2024 there will be a pot-luck **AWARDS:** Completion awards available for pick-up at registration. Top Ten and First to Finish on Friday will be announced and handed out at the Friday night ride meal. Saturday's awards will be given 30 minutes after the completion of each ride distance. Ride meals will be set to begin at 6:30 each day

FOOD: Thursday, Friday, and Saturday Night meals will be available - reservation must be RECEIVED by November 20, 2024 to guarantee food.

Statement of Rider Liability Waiver

I wish to enter and participate in the JD’s Carolina Endurance Rides, to be held on Thursday through Sunday, November 29-30, 2024. I have read the rules, conditions, and regulations of the event and will comply with them. As a participant in the Carolina Endurance Ride, I agree to abide by the rules of all applicable sanctioning organizations, including American Endurance Ride Conference (AERC), Southeast Endurance Riders Association (SEERA), Southeast Distance Riders Association (SEDRA), Ride and Tie (RATA) and the aforementioned ride. I hereby knowingly execute this waiver of the right to sue and do hereby agree to assume all risks associated with participation in the Carolina Ride. I agree that my participation in the ride involves certain inherent risks, which include, but are not limited to, the following: (1) horseback riding involves being in remote areas for extended periods of time, far from communications, transportation, and medical facilities; that these areas can have many natural and man-made hazard which ride management cannot anticipate, identify, modify or eliminate, these hazardous surface/subsurface conditions including such things as rocks, trees, puddles, streams, fences, jumps and/or other hard objects and/or holes, divots, ledges which could cause an equine to trip and/or fall and/or could strike a participant who falls from or is thrown from an equine; (2) that horses can behave in unpredictable ways which can result in accidents to anyone at any time, resulting in injury, severe injury, or death; (3) that an equine’s reactions to sound, movements, objects, vehicles, persons, animals, scents or insects cannot be predicted. I agree to take full responsibility for myself/my child, and the animal I/my child is riding. I will hold harmless the AERC, SEERA, SEDRA, RATA its officers and all individual members thereof, Carolina Ride Staff, all ride personnel, any of its affiliated companies, and all property owners over whose land the ride crosses, their representatives, successors and assigns, for any accident, injury or loss that might occur due to my participation in this ride, and free from all liability for such injury or loss, including that due to negligence not caused by wanton or willful misconduct of the Carolina Ride or ride personnel. This release extends to all claims of every kind and nature whatsoever, whether known or unknown, and I expressly waive any benefits that I may otherwise have under provisions of the law of South Carolina relating to the release of known claims. I understand that this release constitutes a limitation on my legal rights.

South Carolina Law States SECTION 47-9-720. Equine liability immunity; exceptions to grant of immunity.

(A) Except as provided in subsection (B), an equine activity sponsor or an equine professional is not liable for an injury to or the death of a participant resulting from an inherent risk of equine activity, and no participant or participant's representative may make a claim against, maintain an action against, or recover from an equine activity sponsor, or an equine professional, for injury, loss, damage, or death of the participant resulting from an inherent risk of equine activity.

I hereby certify that my horse is not under the influence of medication and will not be treated with or given any medications prohibited by AERC rules. I also hereby give permission to AERC or its duly appointed agent to take any appropriate action deemed necessary to check for possible administration of drugs to my horse. The undersigned verifies acceptance of risks and responsibilities for rider’s and horses’ conditions and certifies that all information on this form is correct to the best of his/her knowledge.

THIS AGREEMENT IS BINDING UPON MYSELF, MY SPOUSE, LEGAL REPRESENTATIVES, HEIRS, EXECUTORS AND ASSIGNS. I HAVE READ THE ABOVE, UNDERSTAND IT, AND AGREE TO ABIDE BY THIS.
